New Aide Memoire A Capacity Development Workshop on

Decentralised Governance and Poverty Reduction

Organised by UNDP/BDP/IDG as part of the Global Forum on Re-inventing Government 10 – 11 December 2002

Marrakech, Morocco

Background

The institutions of democratic governance are a key means to achieve the goals of sustainable human development. Decentralisation and local governance are increasingly recognized as basic components of democratic governance as providing the enabling environment in which decision-making and service delivery can be brought closer to local people, especially the poor.

Decentralised governance provides the legal, administrative and fiscal frameworks for the empowerment of people and their institutions at sub-national levels, from the regional or provincial, to the district, to cities, towns and villages. Capacity development of various levels of government, civil society and the private sector, and their partnerships, becomes the key factor for successful decentralization. However, for decentralization and local governance to foster the goals of people-centred, sustainable development, policies and programmes must be designed and implemented in such a way as to ensure the functional linkages between participatory institutional mechanisms and processes and the empowerment of the poor, of the female population and other disadvantaged groups.

Programmes of international donors, including UNDP, have attempted to make these linkages explicit and concrete. These include efforts at the country, regional and global levels. UNDP has increased its financial allocations to decentralization and local governance six-fold in the past decade. Today, this is a major area of support in almost 90 countries in every region. UNDP has recently launched a global trust fund service line and a global knowledge network (community of practice) in this area.

Objectives

In this workshop the major experiences and lessons of UNDP will be shared with the group in order to spark a lively dialogue involving the sharing of insights from each participant. In this way, the workshop will comprise a microcosm of a global knowledge network on decentralization. Therefore, the objectives of the workshop will include:

- 1. To share major lessons and tools through a panel of how decentralization, local governance and urban development have improved the lives of the poor
- 2. To conduct an interactive dialogue through small group discussion
- 3. To pull together insights in a workshop plenary and prepare a presentation for the plenary of the whole conference

Programme

The workshop will take place simultaneously with ten other workshops on themes related to capacity development. On the first day, these workshops will be preceded by an opening ceremony and a plenary session. On the second day, a plenary session will be held after the conclusion of the parallel workshops.
