Workshop Objectives

- 1. Outline a comprehensive view of providing access to services and poverty reduction within the framework of Millennium Development Goals, particularly Goal 7 and target 10 and 11. More specifically, demonstrate how and why addressing the problems of the poor and the slum dwellers should be an integral part of national and local development strategies, as well as good governance policies and practices.
- 2. Share experiences of urban best practices that focus on the need to effect improvements in three, closely related categories: urban governance, local economic growth, and poverty reduction. The best practice presentations would highlight institutional, political and policy changes (i.e., comprehensive development strategies, as opposed to isolated projects; reliance on the resources and strengths of the poor, as opposed to solely top-down, imposed reforms, ¹ etc).
- 3. Recognize that the needed changes (for example, expanding infrastructure and service provision, increasing the supply and reducing the cost of land for housing, targeting municipal services to the poor) require urban governance reforms, and a participatory framework that draws in and involves all stakeholders.
- 4. Demonstrate how well governed cities with a pro-poor focus (i.e., with proactive equity-driven policies) can meet the MDGs
