EXPLANATORY NOTES:

- * The ESC Directory on legislations is based on a preliminary research conducted by UNDESA on ESCs. Information on the legislations were obtained from publicly available and internal UN resources. Some of these information were also verified by the ESCs. Website links are provided for legislations verified by the ESCs and legislations which were obtained from publicly available resources. Further research is currently being conducted to enhance and strengthen the Directory on ESC Legislations.
- (1) This category includes ESCs established through a constitution and organic law. An organic law is defined as a system of laws which forms the foundation of a government, corporation or other organization's body of rules. A constitution is a particular form of organic law for a sovereign state.
- (2) This category includes ESCs established through a Presidential Decree, Executive Order and Executive Directives.
- This category pertains to a directive or order issued by the President or the head of the executive branch of the federal government.
- (3) Legislation refers to a law which has been enacted by a legislature or other governing body. The term may refer to a single law, or the collective body of enacted law.
- (4) This category includes ESCs established by a combination of different forms of legislations which include presidential decree, organic law, legislation and other types of legislation. In some cases, the type of legislation may change when amendments to the original law are enacted.
