**DISCUSSION QUESTIONS**

**What is the purpose of the Expert Group Meeting?**

The purpose of the meeting is to provide a platform for experts to (a) exchange views on challenges, emerging issues and trends related to e-government for sustainable development, (b) identify possible thematic areas, emerging issues and e-services relevant to the *United Nations E-Government Survey 2016* from a sustainable development perspective, (c) review the Survey’s methodology and discuss possible assessment measures for the identified issues and e-services.

**What are the expected outcomes of the Expert Group Meeting?**

The EGM is expected to achieve the following outcomes:

- (1) Common understanding of the critical role of e-Government in promoting sustainable development and enhanced knowledge of current e-government challenges and innovative approaches to address them
- (2) Suggestions on key thematic areas, relevant issues and e-services for advancing sustainable development pillars and their integration to be considered in the United Nations E-Government Survey 2016 in line with the post-2015 development agenda
- (3) Recommendations on possible enhancements to the Survey’s methodology
