



2. 1) Introduction of Open Consultations

Rationale of the Open Consultations

- To allow for a more inclusive, open and participatory approach in the design of the United Nations E-Government Survey, in response to requests from Member States to have a greater role in enhancing the Survey and its methodology
- The open consultations as part of the preparatory process for the upcoming edition is the first to include consultations from both online and offline channels in order to obtain feedback on the latest Survey and suggestions for the upcoming 2016 edition



2. 1) Introduction of Open Consultations (continued)

Focus/ Scope of the Open Consultations

The open consultation for the Survey 2016 includes:

- **Consultative Meetings** – insights on current challenges and emerging trends and innovative e-government practices for sustainable development from UN Member States as the inputs to defining thematic areas and enriching the methodology
- **Online consultations** – feedback and suggestions for the Survey enhancement from various stakeholders
- **Expert Group Meeting** – recommendations from Experts on how to link e-government for sustainable development

2. 1) Introduction of Open Consultations (continued)

Coverage of the Member States



- A total of 100 countries have participated
- Senior government officials, CIOs or equivalent positions with specific responsibilities concerning e-government policy design and implementation
